AN ACT

To amend chapter 15 of title 38, United States Code, to provide that where a veteran receiving pension under this chapter disappears, the Administrator may pay the pension otherwise payable to the wife and children.

Veterans. Pensions. 72 Stat. 1134. Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That (a) subchapter I of chapter 15 of title 38, United States Code, be amended by adding at the end thereof the following new section:

"§ 507. Disappearance

"Where a veteran receiving pension under subchapter II of this chapter disappears, the Administrator, in his discretion, may pay the pension otherwise payable to his wife and children. In applying the provisions of this section, the Administrator may presume, without reports pursuant to section 506(a) of this title, that the status of the veteran at the time of disappearance, with respect to permanent and total disability, income, and net worth, continues unchanged. Payments made to a wife or child under this section shall not exceed the amount to which each would be entitled if the veteran died of a non-service-connected disability."

(b) The table of sections at the head of subchapter I of chapter 15 of title 38, United States Code, is amended by adding at the end

thereof the following:

"507. Disappearance."

AN ACT

To provide for the striking of medals in commemoration of the one hundredth anniversary of the founding of the United States Secret Service.

June 24, 1966 [H. R. 10357]

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That, in commemoration of the one hundredth anniversary of the founding of the United States Secret Service, the Secretary of the Treasury (hereinafter referred to as the "Secretary") is authorized and directed to strike bronze medals of a suitable size, and with suitable emblems, devices, and inscriptions to be determined solely by the Secretary.

Sec. 2. The Secretary shall cause such medals to be struck and sold by the mint, as a list medal, under such regulations as he may prescribe, at a price sufficient to cover the cost thereof, including labor,

materials, dies, use of machinery, and overhead expenses.
